### **Greenearth Energy Ltd (GER)**

#### **Issue of Placement Shares – Notice under section 708A(5)(e) and Listing Rule 3.10.5A**

Greenearth Energy Ltd (GER) (**Company**) gives this notice under section 708A(5)(e) of the Corporations Act (Cth) (**Act**), further to its share placement to raise approximately \$4.2 million before costs as announced on 1 April 2015 (**Placement**).

Under the Capital Raising, the Company issued 49,395,000 fully paid ordinary shares at an issue price of 8.5 cents per ordinary share (**New Shares**) on 10 April 2015.

The Company provides the following information in respect of the Placement:

1. The Company issued the New Shares without disclosure to investors under Part 6D.2 of the Act.
2. As at the date of this notice, the Company has complied with:
  - a. the provisions of Chapter 2M of the Act as they apply to the Company; and
  - b. section 674 of the Act.
3. There is no excluded information as described in section 708A(7) of the Act and qualified by 708A(8) of the Act
4. The Company provides the following information under ASX Listing Rule 3.10.5A:
  - a. A total of 49,395,000 shares were issued under the Placement. A total of 19,758,000 shares were issued pursuant to Listing Rule 7.1A (representing 8.00% of the post-placement capital) and 29,637,000 shares were issued pursuant to Listing Rule 7.1 (representing 12.00% of the post-placement capital).

The percentage of the post-placement capital held (in aggregate) is as follows:

- pre-placement security holders who did not participate in the Placement – 68.14%
- pre-placement security holders who did participate in the Placement - 17.02%
- participants in the Placement who were not previously security holders - 14.84%

- b. The Company considered the Placement as the most efficient and expedient method for raising the funds required to achieve its stated objectives given the funding certainty.
- c. The Placement was not underwritten.
- d. Fees and costs totalling approximately \$0.2m were incurred in connection with the Placement.
